## **NOTICE**

As per section 5 of the Goa (Recovery of Arrears of Tax through Settlement) Act, 2009 (Goa Act 17 of 2009) (hereafter referred as the "said Scheme"), the extended last date for making an application under the said scheme is 31<sup>st</sup> day of January, 2021.

Hence, any applicant may file an Online application for settlement in Form I within the above mentioned extended time limit i.e. 31/01/2021 and also ensure due compliance of section 5(1B) of the said Act by taking print out of downloaded Acknowledgment and signing and verifying the same as per section 5(1B) of the Act and submitting it to the Designated Authority at its Office within 15 days online filing or within the time limit for making application as specified u/s. 5(1) of the Goa (Recovery of Arrears of Tax through Settlement) Act, 2009, WHICHEVER IS EARLIER. Therefore, the signed print out of Form I should be submitted to Designated Authority latest on or before 31/01/2021.

However, since 31/01/2021 is a holiday being Sunday, as per section 4 of the Limitation Act, 1963 (Central Act No. 36 of 1963) the signed print out of

Form I shall be treated as validly submitted if it is submitted in the office of Designated Authority on 01/02/2021 before closing of the office at 5.45 p.m..

Any signed print out of Form I submitted in the office of Designated after 01/02/2021 shall be summarily rejected.

Hence, all applicants are requested to take note of this and ensure submission of signed print out of all Form I filed online latest by 01/02/2021 before 5.45 p.m.

All Ward Offices shall be kept open on Saturday 30/01/2021 and Sunday 31/01/2021 during normal working hours i.e. from 9.30 a.m. to 1.15 p.m. and from 2.00 p.m. to 5.45 p.m. only for the purpose of accepting signed Form I print outs at respective Inward Counters to avoid last minute rush for submission of signed copies.

All Dealers/Hoteliers/Traders are requested to avail the benefits of said Scheme by making timely compliance.
