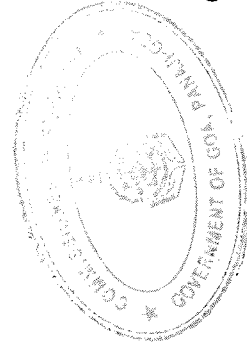
- 1) Upper Division Clerks (UDC);
