ORDER

The Addl. CST (HQ) may also exercise all powers of sanctioning delegated to DCST (Admin) at H.O. or S.T.O. incharge of ward offices in exigencies.

The respective STO incharge of ward office shall exercise all powers of sanctioning as delegated above in respect of officials posted under their control on regular basis and Addl. CST (HQ) and/or DCST (Admin) may also exercise all powers of sanctioning delegated to S.T.O. incharge of ward offices in exigencies.

The above powers shall be exercised strictly in adherence to Rules and Regulations of Government as applicable from time to time.

This Order shall come into force with immediate effect.
