**Sub: Delegation of Financial powers under the Goa Delegation of  
Financial Powers Rules, 2008.**

**ORDER**

In supersession of the order referred above and in exercise of powers vested in me as Head of Department under Rule 13 of the Goa Delegation of Financial Power Rules, 2008, the Additional Commissioner of State Tax (HQ), is hereby declared as “Head of Office” for the Office of the Commissioner of Commercial Taxes, Altinho, Panaji Goa.

Further, in terms of Rule 12(3) of the Goa Delegation Financial Rules, 2008, the Additional Commissioner of State Tax (HQ) is hereby authorized to exercise the powers, in respect of Part I Section (A) & Section (B) and Part II – Table A of Annexure –VI of the Goa Delegation of Financial Powers Rules, 2008 to incur expenditure on the following items: -

1. Full powers for all the items specified in PART-I Section- (A)
2. Restricted powers for below listed items specified in PART-I Section- (B)
  - a) Maintenance, upkeep, repairs of all types of vehicles upto Rs. 50,000/- per annum in each case.

b) Powers upto Rs. 60,000/- in each case on execution of petty works and special repairs to Government owned buildings, including sanitary fittings, water-supply and electric installations in such buildings and repairs to such installations either departmentally or through P.W.D. The procedure laid down for execution of works in the General Financial Rules, 2017 shall be followed.

3. Powers to incur contingent expenditure for items not covered under Part-I for recurring expenditure Rs. 25,000/- and non-recurring expenditure Rs. 1,20,000/- in each case.

The above powers shall be exercised strictly in adherence to Rules and Regulations of Government as applicable from time to time.
